**2018 Nebraska Swimming Pool Operator Clinic Schedule**

**NOTE: NDHHS Pool Clinics only – PRE-REGISTRATION & PRE-PAYMENT are REQUIRED to attend classes. Complete and return the application with a \$40.00 examination fee per individual, along with check or money order. NO WALK-INS.**

**Owners:** please make copies of the application for your operators, or direct them to the website to print a copy.

*Conducted by the Nebraska Department of Health and Human Services (NDHHS), Division of Public Health or the Lincoln-Lancaster County Health Department (LLCHD)*

**What does being certified mean?**

A certificate of competency means that an individual has attended an operator's clinic and has passed the clinic exam.

**Why should I be certified?**

Nebraska regulations, Title 178 NAC 2, Operation and Management of Public Swimming Pools requires Class A swimming pools to be under the direct and immediate supervision of a certified individual and all Class B and F pools must be supervised by a certified individual who can be on-site within 60 minutes and is responsible for compliance with the regulations.

**What is the cost?**

Fees: **\$40.00** for NDHHS clinics. Pre-payment is required prior to the clinic. You will not be allowed to take the exam unless payment has been received. Payment can be made by check or money order. NDHHS cannot accept credit card payments.

Fees: **\$60.00** for Lincoln-Lancaster County Health Department clinics.

**Is it necessary to pre-register and pre-pay?**

All classes except those in Lincoln require pre-registration and pre-payment. See schedule for clinic information.

**What if I fail the exam?**

You may retake the exam at a later date, but it is treated as a new test and must be accompanied by the appropriate fee.

**Important Information**

1. **Picture ID is required for admittance to clinic and exam.**
2. **Study material is available online. You will watch a DVD during the clinic, which is not online.**
3. **Exams will not be graded the day of the pool clinic.**
4. **Individuals currently certified by NDHHS cannot attend a NDHHS clinic if their certificate expires 90 days BEFORE the clinic date.**
5. **For questions concerning a NDHHS issued certificate, please call 402/471-0903. For questions concerning an LLCHD issued certificate, please call 402/441-8002.**
6. **A certificate is valid for 2 years.**
7. **If you have a current pool operator's certificate from the National Swimming Pool Foundation (CPO), the Aquatic Facility Operator Certificate (AFO) approved by the National Recreation and Park Association, the Licensed Aquatic Facility Technician Course by the American Swimming Pool and Spa Association or an equivalent certificate, it is not necessary to also be certified by NDHHS.**
